PLEA AGREEMENT

On this _______, and the State by Marcia Ashdown, Prosecuting Attorney, and by Assistant Prosecuting Attorney Perri Jo DeChristopher, and also came the defendant, Rachael Shoaf, in person and with her attorneys, John Angotti and David Straface, and entered into a plea agreement in the above-styled case, subject to the approval of the Court, and they do hereby agree as follows:

- The defendant will plead guilty to Murder in the Second Degree, a 1. felony as charged by prosecutor's information.
- All parties agree that the State of West Virginia maintains jurisdiction to 2. prosecute the offense charged as part of this agreement, pursuant to West Virginia v. Dennis, 607 S.E.2d 437 (W.Va. 2004); Heath v. Alabama, 474 U.S. 82 (1965).
- In recognition of the assistance to the investigation provided by the 3. defendant, the State will recommend a sentence of twenty years of incarceration.
- The defendant will make a sentence recommendation requesting that the 4. Court sentence the defendant as a juvenile, pursuant to WV Code § 49-5-13(e) and/or any other form of alternative sentence. The State will oppose any such a request.
- The defendant agrees she shall not challenge the validity of this criminal 5. conviction by direct appeal in federal or state court, or in any legal proceeding including but not limited to state or federal habeas corpus petition.
- In the event that this plea agreement is voided, all parties all parties agree 6. that all parties will be returned to the legal positions that they occupied immediately prior to the initiation of this criminal prosecution. All parties

shall have the right to seek enforcement of this agreement in any court of law.

The defendant will be required to offer truthful and forthright testimony in 7. any subsequent proceeding deemed necessary by the State of West Virginia or any other jurisdiction regarding the facts and circumstances of this crime.
