# II. SUBCOMMITTEE ACTION PLAN

# **Completed Action Steps**

- a. <u>Community Education</u>. The Prevention Subcommittee has prioritized community education initiatives, including:
  - Participation in health fairs,
  - Drug trends presentations,
  - "Scare Tactics Don't Work" presentations,
  - Creation of brochures,
  - Drug tip-line information,
  - Disseminating information on drug resources, and
  - Evidence based program training.
- b. <u>Evidence Based Programming</u>. The Prevention Subcommittee has implemented several evidence based programs, including:
  - Alcohol Literacy Challenge, and
  - Too Good for Drugs.
- c. <u>Community Development</u>. The Prevention Subcommittee has focused on community engagement by developing and working with community groups, including:
  - County Prevention Coalitions, and

- Youth Prevention Coalitions.
- d. <u>Media Relations</u>. The Prevention Subcommittee has collaborated with the News Media Subcommittee to create a public service announcement for the Harrison County Prevention Partnership Community Substance Abuse Prevention Walk.

- a. Access to Opioid Antagonists. The Prevention Subcommittee will collaborate with the Law Enforcement Subcommittee to implement a pilot program to increase the availability of opioid antagonist medications, namely Naloxone or Narcan, to law enforcement officers in the region. Specifically, the Prevention Subcommittee will assist the Law Enforcement Subcommittee in identifying appropriate mental health and substance abuse treatment resources in the region. These resources will be available for law enforcement officers to recommend to individuals revived with an opioid antagonist medication. Additionally, the Prevention Subcommittee will assist in tracking and analyzing data associated with the pilot program. Finally, the Prevention Subcommittee will collaborate with the United States Attorney's Office to educate the community with respect to two new pieces of legislation passed in West Virginia, the Access to Opioid Antagonist Act (Narcan Act), and the Alcohol and Drug Overdose Prevention and Clemency Act (Good Samaritan Law).
- b. <u>Community Education</u>. The Prevention Subcommittee will prioritize community education and awareness of substance abuse prevention, including:
  - Community educational workshops,
  - Billboards,
  - Public service announcements,
  - Newspaper articles,
  - Radio segments.
- c. <u>Youth Empowerment</u>. The Prevention Subcommittee will collaborate with the News Media Subcommittee to create a series of videos/public service announcements designed and created by local youth. This effort will be led by students from each Harrison County High School which form the Harrison County DREAM Team (Teens Encouraging Advocacy and Motivation). These videos will also be displayed at sporting events and school activities to promote awareness.
- d. <u>Drug-Free Youth Activities</u>. The Prevention Subcommittee will host a variety of safe, drug-free activities for local youth and the community.
- e. <u>Community Engagement</u>. The Prevention Subcommittee will undertake various community mobilization and engagement initiatives, including:
  - Continued prevention coalition meetings and initiatives,
  - Collaboration with other community groups, and
  - Collaboration with other subcommittees of the Addiction Action Plan.

f. <u>Syringe Exchange Program</u>. The Medical Subcommittee will collaborate with the Recovery Subcommittee and the Prevention Subcommittee to establish and implement a syringe exchange program in the region.

# **Completed Action Steps**

- a. <u>Community Engagement and Education</u>. The News Media Subcommittee has emphasized the awareness of substance abuse by increasing media coverage of this topic, including:
  - WBOY-TV produced and aired a multi-part series on Narcan in West Virginia,
  - WBOY-TV produced a public service announcement for the Harrison County Prevention Partnership Community Substance Abuse Prevention Walk.

- a. <u>Youth Empowerment</u>. The News Media Subcommittee will collaborate with the Prevention Subcommittee to create a series of videos/public service announcements designed and created by local youth. This effort will be led by students from each Harrison County High School which form the Harrison County DREAM Team (Teens Encouraging Advocacy and Motivation). These videos will also be aired on local TV stations, including WBOY-TV, and displayed at sporting events and school activities to promote awareness.
- b. <u>Collaborative Marketing</u>. The News Media Subcommittee will interface with the other subcommittees which comprise the United States Attorney's Office Addiction Action Plan to promote their initiatives and goals with respect to preventing and reducing substance abuse in the region.

- b. Hire additional elementary school counselors with specific focus and expertise on drug prevention therapy and counseling.
- c. Increase awareness of the impact of prescription drug abuse.
- d. Education parents and students about the signs of drug addiction and empower them to seek resources for help.

# II. SUBCOMMITTEE ACTION PLAN

# **Completed Action Steps**

a. <u>Focus Groups</u>. The Education Subcommittee held a variety of focus group meetings, including with student mentors, to develop recommendations on types of education program and materials that would be impactful to students, parents, and the general public.

- a. <u>Availability of Resources</u>. The Education Subcommittee will develop a series of links of the regional board of education websites to resources for substance abuse prevention, education, and treatment.
- b. <u>Youth Empowerment</u>. The Education Subcommittee will collaborate with the Prevention Subcommittee and the News Media Subcommittee to design and produce anti-drug public service announcements. These will be displayed at school functions including athletic events and theatre performances.
- c. <u>Drug Testing</u>. The Education Subcommittee will explore the feasibility of drug testing as a prerequisite to participation in certain school activities, including athletic teams.

- a. Assist people with addiction and their families to effectively access and utilize existing support groups.
- b. Develop additional support group/recovery resources.
- c. Assist service providers to effectively access and utilize existing support groups in their communities.
- d. Develop standardized protocols and funding for the utilization of Peer Recovery Coaches.
- e. Standardize the process of accessing and utilizing community support groups.

# II. SUBCOMMITTEE ACTION PLAN

- a. <u>Community Education</u>. The Recovery Subcommittee will implement various community education and engagement initiatives, including:
  - Educating the community regarding the available recovery resources in the region, including providing information and standardized training to treatment providers, community corrections professionals, human services agencies, and religious associations,
  - Developing standardized protocols for Peer Recovery Coaches in the region, and
  - Collaborating with the News Media Subcommittee to promote available recovery resources in the region.
- b. <u>Utilization of Recovery Resources</u>. The Recovery Subcommittee will develop recommendations that would require individuals enrolled in treatment to participate in

- support group or recovery programs. The Recovery Subcommittee will also develop recommendations that would require any medical provider applying to distribute opioid medications to provide recovery and support group resources.
- c. <u>Syringe Exchange Program</u>. The Recovery Subcommittee will collaborate with the Medical Subcommittee and the Prevention Subcommittee to establish and implement a syringe exchange program in the region.

# II. SUBCOMMITTEE ACTION PLAN

# **Completed Action Steps**

- a. Narcan Legislation. The Business and Legislation Subcommittee sponsored and supported the *Access to Opioid Antagonist Act*, which limits criminal liability for individuals who carry and administer an opioid antagonist medication, such as Naloxone or Narcan, to an individual who is experiencing and opioid-related overdoes. The goal of this legislation is to prevent deaths in circumstances involving individuals who have overdosed on opiates.
- b. <u>Good Samaritan Legislation</u>. The Business and Legislation Subcommittee sponsored and supported the *Alcohol and Drug Overdose Prevention and Clemency Act*, which limits criminal liability for individuals who report an overdose situation to authorities and emergency medical personnel. The purpose of this legislation is to encourage citizens to intervene in drug and alcohol overdose situations by seeking potentially life-saving emergency medical assistance for others without fear of being subject to certain criminal penalties.

- a. <u>Community Education</u>. The Business and Legislation Subcommittee will partner with the United States Attorney's Office to educate community groups about the practical implications of the Opioid Antagonist Legislation and the Good Samaritan Legislation.
- b. <u>Business Community Engagement</u>. The Business and Legislation Subcommittee will develop programming and initiatives to empower the business community to educate the regional workforce on substance abuse prevention and awareness.

- b. Implement mental health treatment as a component of Day Report Centers.

# II. SUBCOMMITTEE ACTION PLAN

# **Completed Action Steps**

- a. <u>Medication Assisted Treatment</u>. The Community Corrections Subcommittee has initiated efforts to better integrate medication assisted treatment into the community corrections infrastructure with the goal of reducing dependence on opioids.
- b. <u>Mental Health Treatment</u>. The Community Corrections Subcommittee has initiated efforts to increase collaboration between community corrections professionals and mental health resources to ensure that all community corrections participants are evaluated by the appropriate mental heal provider, especially when the participant shows signs of co-occurring disorders.

# **Future Action Steps**

a. <u>Reentry</u>. The Community Corrections Subcommittee will expand and enhance the resources available to individuals returning to the community after being incarcerated.

- b. <u>Evidence Based Programs</u>. The Community Corrections Subcommittee will expand the availability to evidence based practices with an emphasis on intervention.
- c. <u>Expansion of treatment courts</u>. The Community Corrections Subcommittee will coordinate with the U.S. Attorney's Office to develop treatment courts in the federal court system.

- a. Promote best practices for physicians prescribing opioid medications through prescriber education efforts.
- b. Promote prescriber active utilization of the controlled substance surveillance site by all prescribers to combat controlled Substance diversion.
- c. Promote access to take home Naloxone programs to combat overdose fatalities.
- d. Promote best practices for physicians prescribing and co-prescribing take home Naloxone through prescriber education efforts
- e. Promote best practices for physicians and providers providing Medication Assisted Treatment and enhance integration of counseling/therapy as an essential component of Medication Assisted Treatment.

#### II. SUBCOMMITEE ACTION PLAN

- a. Opioid Antagonist Availability. The Medical Subcommittee will collaborate with the Law Enforcement, Community Corrections, and Legislative Subcommittees of the United States Attorney's Addiction Action Plan to increase the availability opioid antagonist medications, such as Narcan or Naloxone, to first responders, Day Report Centers, and individuals struggling with addiction.
- b. <u>Education</u>. The Medical Subcommittee will develop recommendations to improve education for medical professionals regarding the use of opioid medications, including:

- Recommending that the West Virginia Board of Medicine create and issue standardized treatment protocols/best practices for Medication Assisted Treatment,
- Collaborating with the West Virginia Board of Medicine, West Virginia Board of Pharmacy, and the Business and Legislation Subcommittee of the United States Attorney's Addiction Action Plan to enhance the required controlled substances training for medical providers in West Virginia,
- Recommending the creation of a mandatory Continuing Medical Education course by the West Virginia Board of Medicine and the West Virginia Board of Pharmacy related to the use of opioid antagonist medications such as Naloxone or Narcan.
- c. <u>Enhanced Reporting</u>. The Medical Subcommittee will develop recommendations for enhanced monitoring and reporting of controlled substance prescriptions in West Virginia, including:
  - Requiring prescribers to check the West Virginia Prescription Monitoring Program before prescribing any opioid,
  - Enforcing a registration deadline for prescribers to register with the West Virginia Prescription Monitoring Program, and
  - Requiring prescribers associated with the Veteran's Administration to report controlled substance prescriptions.
- d. <u>Syringe Exchange Program</u>. The Medical Subcommittee will collaborate with the Recovery Subcommittee and the Prevention Subcommittee to establish and implement a syringe exchange program in the region.

# II. SUBCOMMITTEE ACTION PLAN

# **Completed Action Steps**

a. <u>Prescriber Education Conference</u>. In June 2015, the Treatment Subcommittee collaborated with the United States Attorney's Office to design and host the 2015 West Virginia Prescriber Education Conference. The conference featured a keynote address from Michael Botticelli, Director of the White House Office of National Drug Control Policy. Attendees from the medical, pharmaceutical, substance abuse treatment, and law enforcement industries were presented with a full day of presentations and panel discussions highlighting best practices in treating pain and prescribing and monitoring the use of narcotic medications. The event was well received and the Treatment Subcommittee will collaborate with the United States Attorney's Office to arrange targeted follow-up initiatives.

# **Future Action Steps**

a. Reentry & Improving Availability of Treatment Resources. The Treatment Subcommittee will undertake an intensive initiative in collaboration with the West Virginia University School of Medicine and the State of West Virginia to analyze the currently available treatment resources within the state and to develop recommendations on improving those resources. Specifically, the Treatment Subcommittee will collaborate with the United States Attorney's Office to evaluate ways to improve treatment resources for inmates returning to regional communities.

- a. Improve the identification and investigation of overdose related deaths.
- b. More effectively identify and prosecute the sources of opioid drugs leading to deaths in the region.
- c. Provide timely and current training for first-responders on best practices in responding to overdoses, both fatal and non-fatal.

# II. SUBCOMMITTEE ACTION PLAN

# **Completed Action Steps**

- a. Overdose Response Policy. The Law Enforcement Subcommittee drafted and disseminated an overdose response policy for adoption by regional law enforcement departments.
- b. <u>Medical Reporting Policy</u>. The Law Enforcement Subcommittee drafted a policy encouraging medical providers to report suspected overdose deaths to law enforcement, including a requirement for the Medical Examiner to report fatal drug overdoses to the appropriate drug task force.

c. <u>Prevention Initiatives</u>. The Law Enforcement Subcommittee has partnered with the Appalachia High Intensity Drug Trafficking Area (HIDTA) program to implement a unique prevention initiative known as the "Give Me a Reason" program. Through this program, free drug testing kits are being provided to residents of Harrison County, West Virginia. The goal of the program is to provide local youth with a tool to resist peer pressure to experiment with drug use and to empower parents to open a productive dialogue to discuss substance abuse with their children.

- a. <u>Prevention Initiatives</u>. The Law Enforcement Subcommittee will continue to partner with the Appalachia High Intensity Drug Trafficking Area (HIDTA) program to implement creative prevention initiatives in the region, including:
  - The "Handle with Care" program will be implemented in the region, and as a result a formal system will be put into place to so that school officials will be notified whenever police officers respond to a dangerous or drug-involved situation where a child is present. School officials will know that a child has been involved in a potentially traumatic situation and that he or she needs to be handled with care.
  - The Appalachia HIDTA educational trailer will be coming to Harrison County and other parts of Northern West Virginia in the near future. The trailer is designed to inform students about substance abuse in an interactive manner.
  - A drug prevention competition will take place for the first time in West Virginia and high schools in Harrison County will participate. This competition will involve students designing educational programming that addresses substance abuse prevention. Students will then present their ideas at a regional competition and one school will be declared the champion.
- b. Access to Opioid Antagonists. The Law Enforcement Subcommittee will develop and implement a pilot program to increase the availability of opioid antagonist medications, namely Naloxone or Narcan, to law enforcement officers in the region. This program will include the development of formalized policies governing the possession and administration of the opioid antagonist medication as well as enhanced education on the newly passed legislation providing limited liability for first responders and community members that carry and administer the medication.
- c. <u>Drug Trends Training</u>. The Law Enforcement Subcommittee will facilitate a West Virginia Drug Trends In-Service training on October 7, 2015 at Mon General Hospital.
- d. Overdose Investigations. The Law Enforcement Subcommittee will establish a monthly "Detective Meeting" among local law enforcement to review all overdose cases, including non-fatal overdoses.
- e. <u>Shift Briefing</u>. The Law Enforcement Subcommittee will collaborate with area law enforcement to establish a briefing program to be conducted at the beginning of each law

- enforcement shift to update officers on new policies and procedures established as part of the United States Attorney's Addiction Action Plan.
- f. Mental Health Education. The Law Enforcement Subcommittee will collaborate with the Prevention and Treatment Subcommittees to design and implement enhanced training for law enforcement officers and other first responders to more effectively recognize and respond to mental health disorders, including but not limited to post-traumatic stress disorder.
- g. <u>Medical Professional Training</u>. The Law Enforcement Subcommittee will educate medical providers on the exception to HIPPA which allows medical professionals to report all overdoses to law enforcement.
- h. <u>Data Analysis</u>. The Law Enforcement Subcommittee will collaborate with the Department of Vital Records to monitor overdose death data.
- i. <u>Legislative Initiatives</u>. The Law Enforcement Subcommittee will collaborate with the West Virginia legislature to assess current sentencing and abuse prevention laws.
