COUNT ONE

On or about August 17, 2011, at or near Clarksburg, Harrison County, West Virginia, the defendant BERNARD FAZZINI did submit a false and fraudulent "Harrison County Purchase Requisition" to the County Commission of Harrison County, while he was an officer of Harrison County, namely County Commissioner, in which he altered, amended and falsified the form and reimbursement receipts, which receipts and "Harrison County Purchase Requisition" form are kept by Harrison County; and, the defendant BERNARD FAZZINI did submit a false and fraudulent "Harrison County Purchase Requisition" with attached false and fraudulent receipts to the County Commission of Harrison County with the intent to enable himself or others to obtain money to which he was not entitled.

All in violation of West Virginia Code § 61-3-22.

## **COUNT TWO**

On or about September 26, 2011, at or near Clarksburg, Harrison County, West Virginia, the defendant BERNARD FAZZINI did submit a false and fraudulent "Harrison County Purchase Requisition" to the County Commission of Harrison County, while he was an officer of Harrison County, namely County Commissioner, in which he altered, amended and falsified the form and reimbursement receipts, which receipts and "Harrison County Purchase Requisition" form are kept by Harrison County; and, the defendant BERNARD FAZZINI did submit a false and fraudulent "Harrison County Purchase Requisition" with attached false and fraudulent receipts to the County Commission of Harrison County with the intent to enable himself or others to obtain money to which he was not entitled.

All in violation of West Virginia Code § 61-3-22.

## **COUNT THREE**

On or about March 2, 2012, at or near Clarksburg, Harrison County, West Virginia, the defendant BERNARD FAZZINI did obtain money in excess of \$1000.00 from Harrison County by false pretenses since on March 1, 2012, the defendant BERNARD FAZZINI, with intent to defraud, submitted a false and fraudulent "Harrison County Purchase Requisition" to the County Commission of Harrison County in which he altered, amended and falsified the form and reimbursement receipts.

All in violation of West Virginia Code § 61-3-24.

**COUNT FOUR** 

On or about June 28, 2012, at or near Clarksburg, Harrison County, West

Virginia, the defendant BERNARD FAZZINI did submit a false and fraudulent "Harrison

County Purchase Requisition" to the County Commission of Harrison County, while he was

an officer of Harrison County, namely County Commissioner, in which he altered, amended

and falsified the form and reimbursement receipts, which receipts and "Harrison County

Purchase Requisition" form are kept by Harrison County; and, the defendant BERNARD

FAZZINI did submit a false and fraudulent "Harrison County Purchase Requisition" with

attached false and fraudulent receipts to the County Commission of Harrison County with the

intent to enable himself or others to obtain money to which he was not entitled.

All in violation of West Virginia Code § 61-3-22.
