

On 08/28/2017, William Sothen and Amber Generally became involved in a verbal argument after a road rage incident while on Van Voorhis Road in the city of Morgantown. Sothen pulled up in the center turning lane beside Generally and exchanged words with her. After arguing, Generally attempted to get back into her vehicle when Sothen stopped her from getting in by pushing her out of the way and slamming her car door shut. Generally retaliated and shoved Sothen. Sothen then proceeded to grab Generally by the neck and took her to the ground where the two engaged in a physical altercation for a brief period of time. Generally got to her feet and attempted to get back into her vehicle a second time when Sothen again, prevented her from getting in her vehicle and pinned her against her car before an off duty WVU officer intervened. Generally had an injury to her ear from her earring being ripped out and a scrape on her right calf.
